PUBLIC FORUM

There was one member of the public present, but they did not ask any questions or made any short statements during the time allocated.

1. REMARKS BY CHAIRMAN

Cllr Spencer welcomed all for attending.

2. APOLOGIES FOR ABSENCE AND REASONS GIVEN

All Parish Councillors were in attendance so there was no reason for any apologies for absence.

3. TO RECEIVE ANY DECLARATIONS OF INTEREST IN ACCORDANCE WITH THE REQUIREMENTS OF THE LOCALISM ACT 2011, AND TO CONSIDER ANY APPLICATIONS OF DISPENSATIONS IN RELATION TO DISCLOSABLE PECUNIARY INTERESTS

Cllrs Shaw, Carey and Stockley declared an interest in *Item 10c* on the agenda.

4. NOTES OF THE MEETING HELD ON WEDNESDAY 28th NOVEMBER 2018 TO BE APPROVED AS THE MINUTES AND TO BE SIGNED BY THE CHAIRMAN

It was resolved to accept these notes as a true and accurate record and thereby signed by the Chairman.

5. TO RECEIVE ANY REPORTS FROM ANY OUTSIDE BODIES

ELDC Cllr Swanson reported the following:

- It has been reported in the Standard that the Transit site at Burgh-le-Marsh located in the Local Plan has been sold.
- The Green Bin Waste Collection is up for renewal. Any resident that either renews or signs up to this scheme by 12th February 2019 could be one of twelve households that receive a free subscription.
- Rob Barlow has officially been appointed Chief Executive of East Lindsey District Council.
- ELDC has agreed the adoption of the Skegness Foreshore Masterplan with an initial investment of £300,000 to improve Tower Esplanade.
- Skegness Town Council are to take control of key assets including Tower Gardens. These will be handed over throughout 2019.
- A new Dog Friendly campaign has been launched.
- ELDC are inviting young people to take part in the first Teenage Market this May.

- The Absent Voter register is being refreshed.

Cllr Swanson informed the Parish Council that he had spoken to the appropriate person at ELDC in regards to the Bin down Watermill Lane not being emptied.

6. PARISH MATTERS

a. Sandpits

Cllr Spencer informed the Parish Council that she has requested an Estate Agent valuation of the land but nothing to date has been sorted. Thereby, she is going to be asking another one to see what options are available.

b. 2019 Newsletter

This is still to be finalised but hopefully will be completed in the next two weeks.

7. HIGHWAYS

The clerk informed the Parish Council that a letter had been received from LCC Highways informing that there will be a road closure of New Lane, Toynton Fenside between 28th February and 4th March 2019.

Cllr Spencer suggested that it would still be worth looking into getting a 20mph limit in the vicinity of the Primary School.

8. PLANNING

a. SN/18/0191 – Street Naming & Numbering of 1 road and 4 dwellings – Land to the West of Main Road, Toynton All Saints

The Parish Council had no objections to this application.
