b. Grant application from Toynton Village Hall

7. HIGHWAYS

a. Parking concerns on the corner of Chapel Lane, Toynton All Saints

A letter had been received from the residents of No. 23 Main Road, Toynton All Saints in response to correspondence sent in relation to this issue which was circulated to the Parish Councillors.

It was decided that this issue did not look like it would be resolved in the nearby future, and with concerns of the ongoing traffic problems and the large vehicles that use this area that a severe incident is likely to occur. Therefore, a suggestion of having double yellow lines painted on both corners of Chapel Lane was made, to prevent any parking in this area and aid the current situation.

The clerk reported that in regards to the slow sign that has constantly been chased, it has been agreed that some slow signs can now be replaced, however, this needs to be programmed into the schedule and thereby no date can be given at the present moment as to when this work will commence.

Cllr Spencer reported that she had been contacted by a resident in regards that ragweed that has been seen growing down Main Road, which is poisonous to the equestrian community who pass this area daily and thereby asked could something be done to get this removed.

8. PLANNING

 a. S/185/01227/18 – Rear single story extensions and alterations to existing dwelling and provision of a car port on the site of an existing conservatory which is to be demolished – Hillside Lodge, Main Road, Toynton All Saints

This application was being viewed by the Planning Forum but it was reported that there was no objection to this request.
