PUBLIC FORUM

1. REMARKS BY CHAIRMAN

Cllr Spencer welcomed those that were attending especially due to current circumstances of which was extremely appreciated.

2. APOLOGIES FOR ABSENCE AND REASONS GIVEN

Cllrs Swanson, Shaw, Stockley and McGregor had forwarded their apologies for absence of which the Parish Councillors were aware of the reasons for not attending of which it was resolved to accept these explanations.

4. NOTES OF THE MEETING HELD ON WEDNESDAY 15th JANUARY 2020 TO BE APPROVED AS THE MINUTES AND TO BE SIGNED BY THE CHAIRMAN

It was resolved to accept these notes as a true and accurate record and thereby signed by the Chairman.

5. TO RECEIVE ANY REPORTS FROM ANY OUTSIDE BODIES

LCC Cllr Bowkett forwarded her apologies due to being away at the time of the meeting.

ELDC Cllr Swanson had forwarded a report due to not being in attendance at the meeting, which the following was read out by the Chairman.

- The total budget requirements for 2020/2021 is £82m. The amount that funds received from the government is £72m of which the shortfall is needed to be raised from the residents within East Lindsey. Thereby the Council Tax was increased by 3.49% and equivalent of 9.5p per week.
- Twenty new vehicles have been procured for Waste Collection which has led to an adjustment to collection arrangements. All households have received a letter advising of the new collection dates.
- The Councillor Community Grant will be again available for 2020/2021 of £1000 per ward member.
- A food proprietor in Skegness has recently been fined and banned from operating.

- ELDC enforcement have been active in stopping vehicles and taking action on the carriage of illegal waste.
- There is a national Keep Britain Tidy Campaign looking for volunteers. ELDC therefore are offering advice to volunteers on Health and Safety and for providing bags and litter pickers. They would also arrange for the waste to be collected from kerbsides.
- Teenage Markets will be returning in the near future in Louth and Horncastle.
- The Lincolnshire Wolds Outdoor Festival is set to be launched in 2021.
- ELDC have set priorities that they would like to achieve by 2030. These are
 - Enable a supply of homes
 - Support Town Centres
 - The natural Environment, Healthy and Active Lives
 - Create a healthy and growing Business Environment
 - Improve Equality of Opportunity
 - Create income for Quality Services for residents including the use of technology.
