PUBLIC FORUM

There were two members of the public present but no questions or make short statements were made during the time allocated.

1. REMARKS BY CHAIRMAN

Cllr Spencer welcomed all for attending the meeting.

All Parish Councillors were in attendance thereby no apologies to be given.

5. TO RECEIVE ANY REPORTS FROM ANY OUTSIDE BODIES

ELDC Cllr Swanson reported the following:

- £25m each has been awarded to both Skegness and Mablethorpe from out of the Government's £3.6 billion Town Fund.
- The 2019 East Lindsey Business Awards Finalists are being reviewed
- The trio charged with the Mustard Gas findings in Woodhall Spa have pleaded guilty.
- A latest report shows that the economic impact of tourism in East Lindsey has increased by £45m between 2017 and 2018.
- A meeting of the Lincolnshire Police and Crime Panel will be taking place on Friday 20th September 2019 at ELDC

7. HIGHWAYS

a. Community Speed Watch

Following the demonstration at the last meeting this matter was discussed further in which it was decided to proceed with this scheme and proceed with looking into purchasing the necessary equipment and seeking volunteers to train.

b. Footpath along Main Road to A16

This item was deferred until the next meeting.

8. PLANNING

a. S/185/01319/19 – Erection of 7 no poly tunnels for the growing of fruit (work commenced) – Jims Field, Peasgate Lane, Toynton All Saints

It was reported that the planning forum had no objections to this planning application, however concerns were raised in regards to the traffic flow to the site from potential customers causing more damage to the current road surface and health and safety issues to pedestrians.

At 7.51pm it was resolved to go back to agenda Item 5

LCC Cllr Bowkett reported the following:

- Commencing from the 1st July 2019 Fire Stations are acting as first responders for residents that have fallen
- The Wellbeing Service commissioned by LCC to run in the ELDC area will be using Spilsby Fire Station as a halfway house to ensure that responders get to residents within the 45 minutes after a call out.
- During the first financial quarter 27596 potholes were repaired, with 6824 still waiting to be done and 1385 queries outstanding.
- During the summer months 760 roads in Lincolnshire have been resurfaced.

Cllr Bowkett informed the Parish Council that the footpath leading to the A16 had not been done as it was too narrow do be done by the slurry machine.

A query was raised to ClIr Bowkett in regards to having a permanent 20mph speed limit outside the school. She replied that it would be believed that this was probably be unlikely but the need would have to be brought to the attention of LCC directly by the school.

An additional question was asked regarding Peasgate Lane being resurfaced. Cllr Bowkett answered that following the tour around the village with Highways a few months back it was agreed that this area would benefit being stoned instead of being tarmacked as this did not comply with being a main road.

At 8.10pm it was resolved to go back to agenda order
