- Asked what is happening with the new laws on changing Sceptic Tanks?
   Cllr Swanson tried to reply to this answer. The clerk looked up for more information on the internet and reported the following:
  - This all changes in 2020. If your property's septic tank discharges to a watercourse, not a soakaway or drainage field, you must replace or upgrade the system by 1st January 2020 or before that date if you are selling your property.
- Concerns were also raised about the speeding of vehicles in Main Road.
